### PONCA TRIBE OF NEBRASKA TRIBAL COUNCIL

#### RESOLUTION 17-

WHEREAS: The Ponca Tribe of Nebraska is a federally recognized Indian Tribe (P.L. 101-484) whose business affairs are conducted by the Ponca Tribal Council as defined in the Constitution approved July 22, 1994 by the Acting Deputy Commissioner of Indian Affairs; and

WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such powers contained in the constitution; and

WHEREAS, the Ponca Tribe of Nebraska has elected to enter into a collaborative partnership with Legal Aid of Nebraska, a nonprofit, nongovernmental, Indian victim services organization, to continue in a program that will address acts of domestic and dating violence, sexual assault, and stalking committed against members or eligible members of the Ponca Tribe of Nebraska, and;

WHEREAS, The Ponca Tribe of Nebraska authorizes Legal Aid of Nebraska to submit an application on behalf of the Ponca Tribe of Nebraska for activities related to the areas specified above, and;

WHEREAS, The Ponca Tribe of Nebraska and Legal Aid of Nebraska support submission of this application to acquire funds to continue providing victims with civil legal services and to provide training targeting the needs of the Ponca Tribe of Nebraska, and;

WHEREAS, the Ponca Tribe of Nebraska will commit to support and work closely with Legal Aid of Nebraska to establish a coordinated community response to stop violence against members or eligible members of the Ponca Tribe of Nebraska, and;

BE IT FURTHER RESOLVED THAT, Legal Aid of Nebraska will be the lead agency in the submission of this application on behalf of the Ponca Tribe of Nebraska and will assume full responsibility for the fiscal integrity as well as program development and implementation of this application.
