

Sioux City Social Dance provides medicine for the people

It was a full house with over 350 people attending the Ponca Tribe of Nebraska sponsored Social Dance at the Sioux City Convention Center Saturday, December 2.

The gathering started with a pipe ceremony lead by Harvey Dreaver (Big River First Nation Cree), who served as Stickman for the dance. Mr. Dreaver is a well-known singer and the lead singer of the international champion drum group, Whitefish Irs, a family drum of the Dreaver family. His mother was a round dance keeper for his people.

As Stickman, Mr. Dreaver was in charge of the singing by passing the drumsticks and some tobacco to each of the invited singers, who in turn sang a set of four songs with help from the other singers.

The evening continued with a community meal followed by singing and dancing, including Round Dance, Two-Step, Kahomni & Side Step Songs. The Social Dance was open to the public and the attire was your best "streetwear." Men's applique shirts and



women's ribbon skirts were popular choices.

Vice Chair Angie Starkel explained, "It's an opportunity for people to come together to take part in the good medicine coming from the singing and dancing, which is especially needed in winter time. Winter time was historically hard for our people with the challenges of survival and continues to be hard in this day and times on many levels. The good feelings and prayers from the social dance are meant to build the people up and to take home with them to help carry them through the winter. As native people we have always known that singing and dancing is truly medicine."

Eight invited singers came from across Canada and the United States, each a member of a championship drum group, along with over 20 more singers and a couple dozen backup women singers. Ponca Tribe of Nebraska member Thomas Hinman, was one of the invited singers.


Attendees came from locally as well as states

away, including a grandmother and a grandson who traveled from 18 hours away in Canada to fulfill the grandson's birthday wish to attend the dance.

Culture & Language Team participate in week of intensive instruction

In early December, the Language and Culture team gathered in Lincoln for in-person instruction with Eagle Rhodd, our Southern Ponca relative, and Language Coordinator Steve Laravie Sr. for a more in-depth learning experience.

In-class studies included Ponca history, new words, short sentences, and having instructors take turns demonstrating what we learned.

The class took a trip to Udi wit'it'agà (Walmart), which can be translated to, "big place to shop, buy or trade." Not every item in the store has

a Ponca word. Older Poncas who didn't know English had tocreate new words for new things using the Ponca vocabulary they already had. An example word might be, "computer" or mázè wédixdì which translates to "metal brain." The language team also went on a hike through Pioneers Park and Nature Center, learning about the wildlife and their habitat, as well as, food, spices, natural herbs, and grasses that were used for healing and medicinal purposes. On the return drive in the car, Eagle, Ricky and Charlie shared some impromptu Ponca singing.

The final day of instruction included a scavenger hunt using Ponca words as clues for the Wagáze wádí (instructor), Eagle Rhodd, to find a gift of appreciation at the end of the hunt.

Domestic Violence January 2024

January is National Stalking Awareness Month: Know It, Say It, Stop It.

In the animal kingdom, predators stalk their prey to kill or overpower them. Stalking is a predatory act. It showcases the power and control one animal wants to have over another.

Stalking is much the same in the human world. It is about power. It is not cute or romantic. Victims of stalking often feel vulnerable, not knowing where their stalker is or when they may show up next. Victims may be on alert, sensing that someone or something is watching them, tracking them.

Stalking is dangerous. Victims may struggle with their responses toward their stalkers. They may try and reason with or appease

a stalker, hoping that being nice will make it stop. Victims may try and minimize their stalking experiences, telling themselves "it's not that bad." Victims may also respond to stalking by confronting or threatening the stalker, or attempting to fight back. While victims cannot control the stalking behavior, they should feel empowered to take steps to keep themselves, their families, and their loved ones safe.

There are numerous resources available to people who are being stalked. Outside of contacting the Ponca Tribe of Nebraska's Domestic Violence Program for assistance, or other local resources, victims may communicate with nationwide resources like: Victim Connect, the National Domestic

Violence Hotline, or the Rape, Abuse & Incest National Network.

New year, new awareness: Human Trafficking Awareness Month

Welcome to January. For some, January is the beginning of a new year. However, for many readers the New Year will not begin until March. The days slowly get longer, minute by minute, and we are quickly headed towards spring, though January and February often feel extremely long. These winter months invite us to slow down, rest, and start planning for the future before March pulls us out of our slumber and gets us excited for new growth and new opportunities.

It has become a Western tradition to set New Year's resolutions. Unfortunately, this tradition has become commercialized, and often has us setting goals that are neither important or sustainable. This year, I encourage our readers to review your New Year's Resolution. Use the time between January and March to plan and set some realistic goals. Ask for help and use this time to reflect. If you do decide to go full speed ahead with a new goal, use the energy of spring that March brings with it to fully implement your plans. Resolutions can be extremely valuable. Our

readers and community our amazing! Set amazing goals for yourself that hold true value!

One goal I would welcome everyone to consider is to set aside some time each month to learn about an issue taking place in your community. Many of us are inundated with problems that are so big and far away that we begin to feel a sense of powerlessness to make things better. Reading this publication every month is a good place to start to learn about issues affecting your community, issues you can get involved in that make a difference for our members.

One such issue affecting all of our Service Delivery Areas is Human Trafficking. January is Human Trafficking Awareness month. In our service delivery areas, you will most commonly encounter sex trafficking.

The Office of Justice Programs published a Native Youth Toolkit on Human Trafficking. There is also plenty of information on this topic at the Human Trafficking Capacity Building Center website. Native American women and men are at risk of sex trafficking. Jurisdictional issues on and near reservations complicate the issue. Unfortunately, prostitution, which is considered a form of trafficking, may be found in casinos around the area.

Additionally, the advancement of technology makes it easier for predators and traffickers to target our children. Facebook and Snapchat are prime locations for traffickers to recruit children and young adults into trafficking schemes.

Where do we start? Speak with your children and family members. Communication is key. Set the example. Would you want your child to act like you? If the answer is no, then maybe some resolutions are in order. We are here to help. Most importantly learn, observe, and trust your intuition. If it feels bad, it probably is.

Calling all Farmers, Ranchers, Rural Landowners, Farmers Markets, and related businesses who have an interest in bolstering your technology; Cyber Security and National Security interested people and businesses that want to learn more about how they can work within the \$1+ trillion-dollar agriculture industry. We have FREE cybersecurity in agriculture online training coming soon! More to come as we begin to create the modules/training. All training will be available virtually, so you may take it in the privacy of your home. In-person training will also be available as we work to set up locations if that is your preference.

Do you have a medical billing concern?

In the event that Ponca Health Services cannot provide the needed specialty care, the PRC program may be available to pay for care administered by private or external healthcare providers. The PRC Program is considered the payer of last resort and Federal Regulations require patients to exhaust all health care resources available to them from private insurance, state health programs (e.g., Medicare, Medicaid) before the PRC program can provide payment. There are several requirements before a patient can be authorized for the program. Please call 402-371-8834 for more information about the PRC program.

Questions to ask yourself when you are referred to an outside doctor:

- 1. Did your Ponca Health Service provider submit a PRC referral?
- 2. Did you consult with the PRC Department about your referral?
- 3. Did you inform the outside doctor's office that you are PRC eligible?
- 4. Did you provide your insurance card to the doctor's office during your visit?

Steps to take when you receive a medical bill in the mail:

- 1. Call the phone number that is located on your patient bill:
 - Inform the office that you received a bill in the mail.
 - · Provide account number and any other information they request.
 - Inquire if they have your insurance information, if not provide it.
 - Inform them that you are Ponca Health Service PRC eligible.
- 2. Submit your bill to the Ponca Health Service PRC Department:
 - PRC does not always know that you have an unpaid medical bill.
 - Please contact a PRC Staff member to discuss your bill.
 - Please submit your most current updated insurance card, so our system can be updated accordingly.

Facts to know about PRC Funds:

- 1. PRC receives yearly funding. It is used from October 1st to September 30th.
- All PRC patient referrals must be approved, otherwise PRC funding will not be applied to your patient bill.
- PRC patients must apply for any alternate resources for which you may be eligible (Medicare, Medicaid, private insurance etc.)
- 4. PRC funding is a Payer of last resort. It pays only for costs not paid for by your alternate resources.

LAW AND ORDER CODE REVISION Discussion on January 23, 2024 at 4:00 p.m. **During Tribal Council Meeting**

The Ponca Tribal Council will be reviewing proposed amendments to the Law and Order Code. The revisions are being considered because the Election Board wants to ensure that the Election Process in 2024 will be fair and impartial.

There are changes being proposed to Title IX. The revisions being considered include but are not limited to the following:

- **Section 9-3-3** Adding a requirement for the Registrar to attend quarterly meetings during odd years and monthly during even years.
- Section 9-3-3 Require the Registrar to send out a voter registration form upon receiving a change of address from a Tribal Member.
- Section 9-3-6 Requiring a registered voter who moves within their voting district to reregister to vote with an updated address and provide the change of address form to the Registrar before ballots are sent out.
- **Section 9-8-2** The process for Petitions for Recall will be changed.

ENROLLMENT COMMITTEE

Tribal membership is central to the health, welfare, economic security, and political integrity of the Tribe and elemental to the Tribe's very existence as a sovereign and independent political community. The purpose of this Title is to implement Article II, Section 2 of the Constitution and provide rules, regulations, and procedures governing the enrollment and honorary membership of eligible individuals in the Tribe as an exercise of the inherent authority of the Tribe.

The Tribal Council is accepting applications for the Enrollment Committee as all terms will be expiring February 1, 2024. Members are paid \$250 stipend per meeting and mileage will be paid for a maximum of 410 miles round trip. All meetings are held in Niobrara, NE. A background check is required.

LANGUAGE AND CULTURE COMMITTEE

The Tribal Council is accepting applications for the Language & Culture Committee as all terms will be expiring on March 9, 2024. Applications are now being accepted. This Committee focuses on the preservation and revitalization of the Ponca language.

The Committee consists of 6 representatives; a representative from each site within the Service Delivery Areas (SDAs) and a representative from outside of the SDAs. Committee members will be selected according to their knowledge of Ponca language, culture, and traditional ways. If a representative is not who meets the above qualification is not available from each site, any qualifying member may be appointed to the committee.

Members will be expected to attend all Committee meetings scheduled monthly and will be paid a stipend of \$250 per meeting and claim associated travel at the government rate, not to exceed a total of 410 total miles.

Some of the responsibilities of this committee are:

- To provide guidance to the Culture Department and Language Program with long-term planning, programming, and the use of traditional knowledge.
- To generate culturally-appropriate programming to increase tribal involvement on culture and language activities and create a sustainable culture and language program for tribal members inside and outside the SDAs.
- To act as a resource for Tribal departments to create culturally-based programming by providing guidance, knowledge, wisdom, and expertise on Ponca culture, traditions, history, and beliefs.
- To assist the Ponca Tribal government in the formulation of policies and procedures pertaining to the Ponca Language, culture, and history.
- To review and approve all Ponca culturally related educational material, such as instructional materials and modern communication media productions, to be used to provide instruction to
- To review and reserve approval on all other activities and tasks related to the Ponca language, history, and culture as may be referred the Committee.
- To periodically assess and review the Language Program and provide such assessments to the Tribal Council.

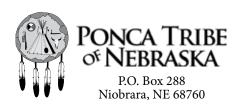
